Undoubtedly, in the last couple of years, the CBIC has rolled out several trade friendly schemes and measures to bolster the Exim trade and constantly working hard towards trying to ring in more dynamic and vibrant measures to facilitate the trade.

However, the main area of concern and one which needs to be addressed immediately is the antiquated style of functioning and following of old out dated procedures and systems. These actually take the sheen off from all proactive and facilitation measures introduced. Many a times, the new trade friendly measures take considerable time in actually being implemented due to resistance from some of the customs officers, who are still around with mindset of British Era.

The attitude and mind set of customs officials, at many custom stations, needs to undergo radical change and transformation. It is evident that many of the custom officers have not yet adapted themselves to the resolve of government in infusing 'Ease of Doing Business' and bringing in sweeping changes to facilitate the EXIM trade. Many officers find it difficult to transform themselves by adopting a role of a 'Facilitator', fearing that they may lose their so called adulterated 'Power' and uncanny authority, thereby, impacting the key and effective trade friendly measures introduced by the Government, from time to time.

CBIC has a significant role to play to ensure that there is total uniformity in procedures and systems at all customs stations in the country. There must be a help desk [of CBIC] at each of the customs zones to address issues on the spot, Besides, CBIC must have regular meetings with Trade associations, every quarter, to iron out all the deficiencies, stream line procedures and systems, and to get an update on the behavior of officers at respective stations. This will go a long way in ensuring instant transformation and will result in smooth implementation of all initiatives and measures introduced by the government.

Liquid Bulk segment is one of the most critical and crucial segment, which needs to be dealt with soft gloves, and, one needs to know and understand the operations and criticality involved in this particular huge revenue generating segment. In fact, Liquid Bulk is one of the significant revenue generating segments for all custom stations and Ports, besides the overall contributions to the main exchequer.

Unfortunately, many a times, policies and procedures being introduced by the CBIC, {undoubtedly for the betterment of the Trade} are not compatible nor connected with liquid bulk trade. The nuances and the operational methods of liquid bulk are totally different from all other segments, and hence, mandatorily need separate policies and procedures which suit this segment and which are easily implementable. It has been observed that all initiatives and trade facilitation measures are framed with keeping in mind containerized cargo segment, machinery etc., but, somehow liquid bulk is unintentionally overlooked, due to unawareness, which results in chaos and hardships.

It is time that CBIC and customs formations, at all ports, realize the immense significance and criticality of liquid bulk trade, and, accord due consideration, priority and handle the same with soft hands.

Undoubtedly, there has been a visible transformation in the attitude of the Custom officials, especially at higher levels, and, in some major customs stations, but, there is still a lot to be done.

We are confident that in times to come, the changes will take place for better, as beginning has already been done, and, it is matter of time that others follow the suit. CBIC will have to ensure that they monitor and enforce strict guidelines with specific timelines to all custom stations to bring about the change in attitude and cement the tag of FACILITATOR once and for all.

The World Customs Organization (WCO), established in 1952 as the Customs Cooperation Council (CCC) is an independent intergovernmental body whose mission is to enhance the effectiveness and efficiency of Customs administrations.

Today, the WCO represents 183 Customs administrations across the globe that collectively process approximately 98% of world trade. As the global centre of Customs expertise, the WCO is the only international organization with competence in Customs matters and can rightly call itself the voice of the international Customs community.

The WCO's governing body - the Council - relies on the competence and skills of a Secretariat and a range of technical and advisory committees to accomplish its mission. The Secretariat comprises

over 100 international officials, technical experts and support staff of some nationalities.

As a forum for dialogue and exchange of experiences between national Customs delegates, the WCO offers its Members a range of Conventions and other international instruments, as well as technical assistance and training services provided either directly by the Secretariat, or with its participation. The Secretariat also actively supports its Members in their endeavors to modernize and build capacity within their national Customs administrations.

Besides the vital role played by the WCO in stimulating the growth of legitimate international trade, its efforts to combat fraudulent activities are also recognized internationally. The partnership approach championed by the WCO is one of the keys to building bridges between Customs administrations and their partners. By promoting the emergence of an honest, transparent and predictable Customs environment, the WCO directly contributes to the economic and social well-being of its Members.

CBIC organises meeting of Regional Heads of Customs Administration of Asia Pacific Region of the World Customs Organisation (WCO) in Kochi

Central Board of Indirect Taxes and Customs (CBIC) is organising a meeting of the Regional Heads of Customs Administration of Asia Pacific Region of the World Customs Organisation (WCO) in Kochi from 08th to 10th May, 2019. India is hosting this meeting in its capacity as Vice Chair of the Asia Pacific region that it assumed on 1st July, 2018 for a two-year period.

The meeting will take stock of the progress being made in carrying forward the programmes and initiatives of WCO to promote, facilitate and secure the cross-border trade in the region and the capacity building and technical assistance required to achieve this goal.

This meeting is being chaired by Mr. Pranab Kumar Das, Chairman, CBIC. Reflecting the importance of the meeting, Customs delegations

from more than twenty countries of the Asia Pacific region are participating, along with senior officials of the WCO and its regional bodies, i.e. Regional Office for Capacity Building (ROCB) and Regional Intelligence Liaoning Office (RILO).

In his inaugural remarks, Chairman, CBIC reiterated the strategic principles guiding India, in its role as the Vice Chair of the Asia Pacific region, which are -

Greater communication and connectivity within the region,

(ii) Harness technology advancements, Inclusive approach, and Consensus on core issues.

Mr Das highlighted the key focus areas on which considerable emphasis should be placed, such as implementation of trade facilitation measures, cross-border e-commerce transactions, building capacity of small island economies and the on-going review of the Revised Kyoto Convention (RKC).

Dr. Kunio Mikuriya, the Secretary General of the WCO, in his address emphasised the role of the

customs in the current global scenario and the crucial role being played by the WCO in streamlining the cross border procedures, and in enhancing the security of global trade.






The average import Dwell Time of all Terminals at @JNPort for June'19 is 19.0 hrs.
